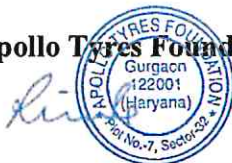

#### 1. Background:

The project addresses the Social Development Goal-3 'Promote Gender Equality and Women Empowerment'. Being heavily dependent on agriculture, livelihood in rural areas could not provide employment for everyone. In the absence of significant industrial growth, there has been severe unemployment and underemployment, resulting in poverty. For most of the poor, fight for survival has been a lifelong mission and natural resources have been the main source of livelihood.

During this long struggle, women have suffered the most. They have to cope up with day-to-day basic needs such as fetching water, collecting fodder and fuel, grinding foodgrains and nursing their children and sick, apart from attending to livestock and agriculture chores.

Women are the backbone of rural and national economies. They represent 49% of the total workforce. In spite of their significant role in supporting the family, women in many regions have no status in the society. They are treated as idle, despite their work schedule stretching throughout the day. They are not expected to participate in decision making and even to express their opinion on matters concerning themselves.

The similar situation prevails in the waghodia block close to the organisation's location. Though the villages are close to urban setup and have influence of urbanisation but still deep rooted with orthodox mentality. Based on this situation Social Responsive Cell (SRC) of Parul University has started its THELLY project in 2020. The project targets to improve the situation of the women by providing them income generation opportunities at their doorsteps.

Theli is a Gujarati word commonly used for carry bag. A usage of bags is one of the major steps towards plastic free spaces and hence this project generates products and brings awareness in rural area. The aim of 'Thelly' project is to start a social enterprise with this innovation to empower the women by enabling mass production of cloth bags also promote plastic free villages/spaces/Environment.

We have started with 50 skilled women from the Madheli village who know stitching work and having sewing machine. Based on success now we have set-up women livelihood centre, where all skilled women shall be invited for the stitching of all type of cloth material based bags.

As Apollo Tyres Foundation also has similar livelihood generation programme in same vicinity with same beneficiaries hence, we approached them for collaborative partnership for this project.

Project Partner shall not take out any press release or do other publicity of any nature regarding this Agreement or its association with ATF, without prior written approval of ATF.

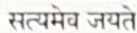

1. **Preamble:**

Whereas CCRAS, an autonomous organization under Ministry of Ayush, Government of India, is a nodal apex body in the country for the formulation and coordination of research in Ayurvedic Sciences in scientific lines. The research area comprises of literature research, literary research including digitalization of medical manuscripts and publication of important Ayurvedic texts, basic and fundamental research in Ayurveda, Drug Research and drug development (comprising of survey, cultivation of medicinal plants and Ethno-botanical research, drug standardization, pharmacology, toxicology etc), clinical research including development of nutraceuticals, cosmetics and reproductive health care research and development of biomedical instrumentation. The research is being executed through 30 field institutes, besides collaborative research with reputed national and international research and academic institutions. Central Ayurveda Research Institute (CARI), New Delhi, a prominent research institute under the CCRAS, located in Punjabi Bagh, New Delhi, with the mandate of clinical research in the field of Ayurveda and caters to health care facilities of general public besides conducting clinical research on various disease conditions of national priority areas. This study will be coordinated by the CARI, New Delhi on behalf of CCRAS.

Uttarakhand Ayurveda University Gurukul Campus, Haridwar, Uttarakhand (Gurukul-Haridwar) cherish its unique position as one of the Ayurvedic institute with large no. of OPD & IPD patients. It follows solely the principles of humanity and serving to mankind since 1921. Presently this college has a well equipped dissection hall, Physiology lab, Ras-shala, an operation theatre, Panchkarma department, pathology labs and about 150 well equipped indoor beds.

Rajiv Gandhi Government Post Graduate Ayurvedic College, Paprola (RGAC-Paprola) is running the undergraduate course (BAMS) and postgraduate MD/MS courses in all the 14 departments. The college has an experienced and dedicated faculty of about 60 teachers who also work as consultants in the hospital to provide high quality of patient care. The college is also working as a nodal center for induction level hands on professional training of Ayurvedic Medical Officers under NRHM programme of the government. 


## 3. PROPOSED MODES OF COLLABORATION

## Memorandum of Understanding

This MoU has been entered on 20-09-2022 between the Forest Department of Surat, District Surat, State Gujarat hereafter called as Forest Department of Surat having its registered office, Forest Department of Surat, District Surat, State Gujarat, and Parul Institute of Architecture and Research, Faculty of Architecture and Planning, Parul University, Parul Arogya Seva Mandal (PASM) called as Training Partner, registered office at Parul University, Limda, Ta-Waghodia, Dist-Vadodara - 391760.

The relevant background and terms and conditions agreed under the MoU are prescribed below.

1. The Forest Department of the Gujarat Government is implementing Van Dhan Yojana, with an objective to enhance the livelihood of tribals who gather MFPs through the formation of SHGs and VDVks across the State. VDKY is a composite program, meant for forest-based tribes. It aims to take the 'MSP for MFP program' to the next level by establishing tribal enterprises and generating livelihoods leading to income enhancement. It is a program for gathering, value addition, processing, packaging, branding & retail-marketing for MFP products through tribal entrepreneurs in the form of tribal-owned SHGs.

The idea is to optimize the tribal income, locally, only through their existing skills and using nontimber forest produces. This is done through the establishment of common-use facilities & infrastructures for value addition, called Van Dhan Vikas Kendras (VDVKs), which are at the initial stages of their implementation.

2. Parul Institute of Architecture and Research, Faculty of Architecture and Planning, Parul University, Parul Arogya Seva Mandal (PASM) (Training Partner) as an organization has been engaged in training and imparting multidisciplinary education. During its existence of nearly 10 years, since 2012, the institute has conducted several educational, training, capacity building programs. A large number of students and organizations have been benefitted through the delivery of training and capacity building to different stakeholders.

Given its organizational competence and the need to enhance the livelihood of tribals who gather MFPs through the formation of SHGs and VDVks across the State, the Forest Department of Surat, has decided to empanel the Parul Institute of Architecture and Research, Faculty of Architecture and Planning, Parul University, Parul Arogya Seva Mandal as a "Training Partner" based on notification published with number 3/2022-23 and evaluation made in the department meeting held on 03<sup>rd</sup> AUGUST 2022 after detailed scrutiny of documents submitted and presentation made by the agency. The empanelled agency shall be responsible for delivering training to the allocated clusters assigned by the Forest Department of Surat.

3. Under this MoU, the agency shall be liable for following scope of engagement and work for delivering cluster-wise training in a batch of twenty for four days;
  - a. The Training Partner Agency shall be engaged by Forest Division, Surat, Gujarat to prepare training modules and teaching aids, mobilization, Interest mapping, counselling, Mentoring, screening, and documentation training on Domain and forward linkage to the gatherers. The training shall be imparted to the trainees as

provided by Department and revised from time to time. The duration of the training for a batch must be in terms of the duration as applicable to the List of trainees approved and suggested by the member secretary of VDVKY.

- b. Curriculum and Training module development
- Training Module and curriculum development for the proposed training program
  - The Content to be developed should be in Gujarati.
  - The Curriculum should incorporate Entrepreneurship Competencies, Marketing, and packaging, Skill grading techniques, Domain Skill, Marketing, Financial literacy, Costing and pricing, and market exposure
  - Incorporation of market-relevant products in the training curriculum
- c. Mobilization of the Gatherers/Trainees
- Prior to initiation of training, ground-level mobilization must be done by Selected Training partners at their own cost
  - The Agency shall be responsible for the coordination of all aspects of the training including quality of training delivery, assessment and certification, and outcomes required from the training.
  - The training partner has to upload/share information of the mobilized gatherers to the department
  - A mobilization plan to be shared with the department before the commencement of the training
  - The training batch should be formed at the Cluster level
- d. Training
- The training program should cover sessions on Domain skills, Entrepreneurship, marketing, packaging, branding, costing, Various marketplaces, Vendors, and market exposure Visits
  - Training data-based to be maintained and reported to FD on a weekly and monthly basis
  - Attendance of the beneficiary/ Photography/artisan must be maintained, and its report to be submitted to Forest Department and relevant RFO on a timely basis

# Memorandum of Understanding

This MoU has been entered on **21-09-2020** between Government of Gujarat, hereafter called GoG; having its registered office, District Development Office at **Gandhinagar** and **Parul Institute of Architecture and Research, Faculty of Architecture and Planning** registered office at **Parul university, Po- Limda, Ta- Waghodia, Dist.- Vadodara**.

The relevant background and terms and conditions agreed under the MoU are prescribed below:

1. Rural Development has been on top priority of systematic development planning of five years plans. Commissionerate of Rural Development, GoG, is primarily responsible for implementing the developmental schemes of the State Government in the rural areas
  - i. Rural development activities in Gujarat State are being undertaken through Panchayati Raj Institutions (PRIs). In its efforts towards effective rural development, Commissionerate of Rural Development has developed several special initiatives under its various schemes. The special initiatives, with the support of high technical inputs, aims at elevating socio-economic status of rural deprived households with sustainable upgradation.
  - ii. Shyama Prasad Rurban Mission undertakes the cluster development Programme (infrastructural development) in rural areas.
  - iii. Vrindavan Gam Yojana has been launched in the year 2017-18. Under this scheme 250 villages have been identified as a Vrindavan Gam. The infrastructural development, beautification and various other developmental programmes are required to be undertaken in the identified village as a Vrindavan Gam.
2. **Parul Institute of Architecture and Research, Faculty of Architecture and Planning, Parul University** as an organization has been engaged in training and imparting education in Architecture, Interior and Urban & Regional infrastructure planning. During its existence of nearly 8 years, since **2012**, the institute has conducted several educational programmes. A large number of students and organizations have benefitted through the delivery of Infrastructure Development Planning.

Given its organizational competence and the need for strengthening Rural Infrastructure Development Planning, the District Development Office would like to contribute to bridge critical Infrastructural gap through various supported activity.
3. For achieving the objectives stated above, the following types of activities will be required to be undertaken by institute.
  - a. Situation analysis for the Vrindavan Village
  - b. Identify critical gap in infrastructural Development of enlisted Vrindavan Villages of the Gandhinagar District, namely, **Hathijan, Limbadia, Pratappura (Balva) and Motipura (Veda)**.



- b. Identify critical gap in infrastructural Development of enlisted Vrindavan Villages of the Gandhinagar District, namely, **Hathijan, Limbadla, Pratappura (Balva) and Motipura (Veda)**.
  - c. The project planning for identified critical gap in infrastructural Development of Vrindavan Villages as per the Draft Guidelines of the Vrindavan Gam Yojana, March 2017, Government of Gujarat.
  - d. Any other work not mentioned above by mutual consent.
4. For the purpose of infrastructural Development of 4 Vrindavan Villages of Gandhinagar District, **Parul Institute of Architecture and Research, Faculty of Architecture and Planning** is assigned the consultancy project and sum of Rs. 4,00,000/- (Rupees four lakhs only) as a consultancy fee.

The stages of payment shall be as follows:

15% of the Consultancy fee	On presenting the Second stage Progress
20% of the Consultancy fee	On presenting the Draft Proposal



## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding ("**MOU**") is entered into by and between:

Social Responsive Cell, Parul University located in Limda, Ta: Waghodia, Dist: Vadodara, Gujarat State is a Private University established under Gujarat Private Universities Act, 2009.

**And**

Don Bosco Snehalaya – A home for the young at Risk & A home away from home – runs by "Jagruti Samaj Sewa Mandal Trust". It is a social and Charitable Trust, registered under the law of Govt of India and Gujarat. (Reg. No. E /4860/ Vadodara, BPT Act – 1950 (29) and recognized by the Ministry of Social Justice and Empowerment of Govt. of Gujarat (Reg. No. DSD/CPD/14-15/58). It works since 2001 for the Holistic Development and Rehabilitation of the children, who are in need of care and protection.

### **WHEREAS:**

The purpose of this MOU is to define the roles and responsibilities of both institutions to start an education centre for children who are residing at "Kaali Das ni Chali", slum area near to Vishwamitri.

Killoi Vidyamandir – an education centre will function in a house with seating capacity of 50 children and basic facilities. A qualified teacher (graduate or TTC with experience of teaching) and a helper will manage the centre. A full-fledged time table will chart out for the children spanning for a period of two hours, for five days a week.

**NOW, THEREFORE,** in view of the above, the Parties agree as follows:

- Social Responsible Cell, Parul University shall provide financial help for one year as per the budget. The term of this project shall start from 1st March. 2022 and end on 28th Feb, 2023.
- The centre shall operate five days a week, Monday to Friday, from 5.30 p.m. to 7:30 p.m. The centre will be closed on holidays and also in case the staff is on leave / not available.
- The teacher will also report to the Child Friendly Vadodara – project team and update monthly progress report of all children.
- The project will be monitored continuously throughout the tenure. It will also involve monthly review and visit by SRC team to the project site.



- Don Bosco Snehalaya is fully responsible to execute street school project (Killol Vidhyamandir) at Kalidas Ni Chali in a proper way.
- Both the parties shall appoint a person for point of contact - Ms. Sreekala P.R. (from Don Bosco Snehalaya) and Mr. Vinod Parmar (Social Responsive Cell, Parul University) to deal with administrative works and project monitoring.
- The use of logo by both the parties would be done by intimating the same by each other. Both the parties shall maintain confidentiality regarding information/ documents during course of MOU.
- MOU would be terminated with prior notice to Don bosco Snehalaya.
- The project will be reviewed after one year then will be decided to be extended or not.
- Total cost of the project shall be given in different installments to Don Bosco Senhalaya by Social Responsive Cell, Parul University
- All notices and other communications shall be sent to the address of each party set forth below:

## MEMORANDUM OF UNDERSTANDING

### 1. PREAMBLE

The **Indian Institute of Technology Guwahati**, incorporated under the Institute of Technology Act 1961 as amended by the Institute of Technology (Amendment) Act, 1994 and established in 1994, represented by its Director (hereinafter referred to as "IITG"). Indian Institute of Technology Guwahati, the sixth member of the IIT fraternity, commenced its academic programmes in 1995. IIT Guwahati is officially recognized as an Institute of National Importance by the Government of India.

and

The **Faculty of Ayurved, Parul University**, established under Parul Arogya Seva Mandal, Act of Indian Medicine Central Council Act, 1970 (48 of 1970. (hereinafter referred to as "FOA, PU"), commenced its academic programmes in 2006. Institution is managed by Parul University established in 2015 with a vision to impart education in Ayurveda to UG, PG and doctorate scholars, patient care through Ayurveda and research.

**INDIAN INSTITUTE OF TECHNOLOGY GUWAHATI (IITG) and FACULTY OF AYURVED, PARUL UNIVERSITY (FOA, PU)**, hereinafter collectively referred to as 'the Parties' and individually as 'the Party' formally agree on a Memorandum of Understanding (MoU) as follows:

The Director of Indian Institute of Technology Guwahati (IITG) and the Dean of Faculty of Ayurved, Parul University, for the purpose of furthering cooperation in education and R&D activities between these two institutions, hereby affirm their intent to promote such academic collaborations and to participate in various academic endeavors.

## 2. OBJECTIVES: *(retain / add / modify whatever is required)*

This MoU envisages the fulfilling of the following objectives:

- (a) **IITG administrative support to FOA, PU:** Cooperation between IITG and FOA, PU for improving or initiating new Bachelors, Masters and Doctoral programmes at FOA, PU;
- (b) **Internship programme at IITG:** Under this programme, FOA, PU UG /PG/ PhD students will visit IITG for period of 2 to 8 weeks to attend a summer internship programme either specifically designed and offered or as part of ongoing research at IITG. IITG may charge a fee per participant, on mutual agreeable terms, to cover the costs, if any;
- (c) **Visiting students:** IITG and FOA, PU will explore possibilities of facilitating FOA, PU students (at UG, PG and PhD level) to attend, as visiting students, semester long courses offered at IITG, as per terms of IITG including a fee as fixed by norms of IITG. FOA, PU may work out its own mapping of credits for its own purpose of credit transfer.
- (d) **IITG Faculty support to FOA, PU:** IITG may permit its faculty to visit FOA, PU for short durations ranging from one week to one year to teach at FOA, PU, on mutually agreeable terms, for capacity enhancement at FOA, PU;
- (e) **FOA, PU Faculty support to IITG:** IITG may consider requests from FOA, RPU Faculty to visit IITG as 'Visiting' Faculty members, as per their designations, for research and teaching activities at IITG for limited durations, on mutual agreeable terms.
- (f) **Short-term Training Programmes:** Development and organization of short-term training and certificate courses by IITG and enabling FOA, RPU faculty / staff / students to take part in ongoing continuing education programmes and courses of IITG;
- (g) Enabling FOA, RPU faculty / students to pursue their Masters and Doctoral programmes at IITG on a full-time basis, as per existing IITG norms;
- (h) Cooperation from IITG for development of new areas of research and development at FOA, RPU;



- (i) **Guidance in infrastructure development:** Extension of technical cooperation in the form of knowhow from IITG for infrastructural development, management and upgradation of library and teaching / research laboratories facilities at FOA, RPU;
- (j) To jointly organize short term continuation programmes, seminars, conferences on topics of mutual interest and invite faculty members from both the institution to participate.
- (k) Each of the institutions will maintain their independent identity, logo symbol, image and make no other claims in their publicity material, media, websites, which is termed to be beyond the scope and nature of activities as incorporated in this memorandum. Each party will consult with and take approval of the other party to use the latter's name, the names of the latter's officials' / faculty members, and the logo for the activities under this MoU, and dissemination of results, on a case-by-case basis.

### 3. COORDINATORS:

The Director, IITG and the Dean, FOA, PU shall be primarily responsible for this cooperation at IITG and FOA, PU, respectively. They may delegate their authority to coordinators whose responsibility will be to:

- (a) initiate action at their respective institutions to implement the provisions of this MoU.
- (b) coordinate and monitor the activities initiated under this MoU.
- (c) National regulations and customs shall be mutually respected.

### 4. GENERAL PROVISIONS

- (a) This MoU shall have an initial duration of FIVE years from the last date of signature, unless either party gives a six-month notice of termination. This MoU may be extended further, in five-year increments, after review and by mutual written agreement.
- (b) This MoU is a non-binding expression of the current intentions of the Parties, and neither Party will incur nor be bound to any legal obligations or expenses hereunder to the other Party until and unless definitive agreements have been negotiated and approved by the management levels of each Party.



## **5. FINANCIAL OBLIGATIONS:**

There will be no financial obligations on both Parties under this agreement.

## **6. INTELLECTUAL PROPERTY:**

IITG and FOA. PU agree to respect each other's right to intellectual PROPERTY. Further, all rights linked to ideas, inventions and patents generated during the MoU, if any, shall remain the common intellectual property of the parties. The Parties shall not pass on or give usage rights of such property to any third Party without the consent of the other Party. **1. PREAMBLE**

**Indian Institute of Technology Madras**, incorporated under the Institutes of Technology Act 1961, having its premises at Sardar Patel Road, Chennai – 600036, represented by Dean, AC (hereinafter referred to as “**IITM**”). Indian Institute of Technology Madras, the member of the IIT fraternity, commenced its academic programs in 1959 is officially recognized as an Institute of National Importance by the Government of India.

and

**Parul University**, having its premises at AP Limda, Taluka Waghodia, Vadodara, Gujarat, established under Parul Arogya Seva Mandal, Act of Indian Medicine Central Council Act, 1970 (48 of 1970. (Hereinafter referred to as “**PU**”), commenced its academic programmes in 2006. Institution is managed by Parul University established in 2015 with a vision to impart education in Ayurveda to UG, PG and doctorate scholars, patient care through Ayurveda and research.

**INDIAN INSTITUTE OF TECHNOLOGY MADRAS (IITM) and PARUL UNIVERSITY (PU)**, hereinafter collectively referred to as ‘the Parties’ and individually as ‘the Party’ formally agree on a Memorandum of Understanding (MoU) as follows:

Dean AC of Indian Institute of Technology Madras (IITM) and the Dean of Faculty of Ayurveda, Parul University, for the purpose of furthering cooperation in education and R&D activities between these two institutions, hereby affirm their intent to promote such academic collaborations and to participate in various academic endeavors.

**2. OBJECTIVES:**

This MoU envisages the fulfilling of the following objectives:

- (a) **IITM administrative support to PU:** Cooperation between IITM and PU for improving or initiating new Bachelors, Masters and Doctoral programmes at PU;
- (b) **Internship programme at IITM:** Under this programme, PU UG /PG/ PhD students will visit IITM for period of 2 to 8 weeks to attend a summer internship programme either specifically designed and offered or as part of ongoing research at IITM as



per the availability and as per IITM norms. IITM may charge a fee per participant, on mutual agreeable terms, to cover the costs, if any.

- (c) **Visiting students:** IITM and, PU will explore possibilities of facilitating PU students (at UG, PG and PhD level) to attend, as visiting students, semester long courses offered at IITM, as per terms of IITM including a fee as fixed by norms of IITM. PU may work out its own mapping of credits for its own purpose of credit transfer.
- (d) **IITM Faculty support to PU:** IITM may permit its faculty to visit, PU for short durations ranging from one week to one year to teach at, PU, on mutually agreeable terms, for capacity enhancement at PU.
- (e) **PU Faculty support to IITM:** IITM may consider requests from PU Faculty to visit IITM as 'Visiting' Faculty members, as per their designations, for research and teaching activities at IITM for limited durations, on mutual agreeable terms.
- (f) **Short-term Training Programmes:** Development and organization of short-term training and certificate courses by IITM and enabling PU faculty / staff / students to take part in ongoing continuing education programmes and courses of IITM.
- (g) Cooperation from IITM for development of new areas of research and development at PU.
- (h) **Guidance in infrastructure development:** Extension of technical cooperation in the form of knowhow from IITM for infrastructural development, management and upgradation of library and teaching / research laboratories facilities at PU;
- (i) To jointly organize short term continuation programmes, seminars, conferences on topics of mutual interest and invite faculty members from both the institution to participate.
- (j) Each of the institutions will maintain their independent identity, logo symbol, image and make no other claims in their publicity material, media, websites, which is termed to be beyond the scope and nature of activities as incorporated in this memorandum. Each party will consult with and take approval of the other party to use the latter's name, the names of the latter's officials'/faculty members, and the logo for the activities under this MoU, and dissemination of results, on a case-by-case basis.

### 3. COORDINATORS:

Dean AC, IITM and the Registrar, PU shall be primarily responsible for this cooperation at IITM and PU, respectively. They may delegate their authority to coordinators whose responsibility will be to:

- (a) initiate action at their respective institutions to implement the provisions of this MoU.
- (b) coordinate and monitor the activities initiated under this MoU.
- (c) National regulations and customs shall be mutually respected.



#### **4. GENERAL PROVISIONS**

- (a) This MoU shall have an initial duration of FIVE years from the last date of signature, unless either party gives a one-month notice of termination. This MoU may be extended further, in five-year increments, after review and by mutual written agreement.
- (b) This MoU is a non-binding expression of the current intentions of the Parties, and neither Party will incur nor be bound to any legal obligations or expenses hereunder to the other Party until and unless definitive agreements have been negotiated and approved by the management levels of each Party.

#### **5. FINANCIAL OBLIGATIONS:**

Some of the activities enumerated in clause 2 (objectives) may involve cost. Parties will mutually discuss cost implications and plan appropriately before undertaking the activities. In case of any agreed cost to be borne by PU, the payment to IITM shall be made in favor of "The Registrar IIT Madras".

#### **6. INTELLECTUAL PROPERTY:**

IITM and PU agree to respect each other's right to intellectual PROPERTY. Further, all rights linked to ideas, inventions and patents generated during the solely developed by either Party under this MoU, shall be owned by the Party that develops it. All rights linked to ideas, inventions and patents jointly developed by the Parties shall remain the joint intellectual property of the parties. The Parties shall not pass on or give usage rights of such property to any third Party without the consent of the other Party. Any such research collaboration to be taken up during due course of time under the ambit of this present MoU shall be legitimized by signing an agreement.

#### **7. ASSIGNMENT:**

The Parties shall not be entitled to assign of any rights or obligations under this MOU without the prior consent in the writing of the owner or the other Parties to this MOU.

#### **8. AMENDMENT:**

Except otherwise provided therein, no addition, amendment, or modification of any part of the MoU shall be effective unless done in writing and signed by and on behalf of both parties by their respective Authorized Signatories.



#### **9. DISPUTE SETTLEMENT:**

Any dispute, controversy, or claim arising out of or in relation to this MoU, including the validity, invalidity, breach or termination thereof, shall be settled by the parties amicably through mutual consultations and negotiations. In case such dispute remains unresolved for over a period of 30 days, shall be referred to arbitration under Arbitration law of India and the amendments thereof. Arbitration to be conducted under Arbitration and Conciliation Act 1996 and the amendments thereon. Seat of arbitration to be Chennai. Language of Arbitration to be English. Both Parties agree to appoint sole Arbitrator in the event of a dispute not resolved within 45 days of filing by either party. Notwithstanding the foregoing, a Party may bring a claim for immediate injunctive relief where appropriate in a court in such jurisdiction. The Parties agree to submit to the laws of India and exclusive jurisdiction of the Courts in/at Chennai.

#### **10. FORCE MAJEURE:**

A party prevented by force majeure from fulfilling its obligations shall not be deemed in breach of such obligations. The said party shall use all reasonable efforts to mitigate consequences of force majeure. At the same time, the Parties shall consult with each other on modalities of further execution of this Memorandum of Understanding. 






## Memorandum of Understanding

Constituent colleges of the university offering technical professional courses, and medical and paramedical courses have been issued approvals by respective Statutory Councils such as MCI, AICTE, PCI, COA, INC, GNC, Ministry of AYUSH, CCH, CCIM, etc... Two diploma colleges in the Limda Campus of the University, which are affiliated to Gujarat Technological University, have also been issued approvals by AICTE for conducting diploma engineering programs. Its registered office is at Post Limda, Waghodia, Gujarat 391760.

which expression shall include its employees, associates, successors, and assigns of the other part

### WHEREAS:

- A. PARUL UNIVERSITY proposes to engage iACE, inter alia, on a non-exclusive basis, to support in providing educational services such as Workshops, Lectures, Training Programs, Visits, Seminars, FDP, STTP, Integrated Courses, and other incidental related areas as agreed between the parties from time to time, which may be communicated by PARUL UNIVERSITY to iACE from time to time.
- B. iACE agrees to provide such services as agreed with PARUL UNIVERSITY relating to the aforementioned services on the terms and conditions mutually agreed between the parties and contained hereinafter.



## **Effective date and duration**

This agreement shall be effective from the 10<sup>th</sup> June 2022 and shall remain in force till the 9<sup>th</sup> June 2025. On the expiry of duration, parties may review and renew this agreement on such terms and conditions as may be mutually agreed between them.

## **1. Services**

Second Party proposes to engage First Party, inter alia, on a non-exclusive basis, to support in providing educational services such as visits, workshops, STTP, FDP, Seminars, Integrated Course, students' engagements, and other incidental and related areas as agreed between the party's work (hereinafter referred to as work/assignment), from time to time, which may be agreed between the parties from time to time.

IACE hereby agrees to render such services to the PARUL UNIVERSITY as may be agreed from time to time relating to service offerings and other incidental and related areas and the details of such services are contained in **Annexure I**.

## **2. Approvals**

Both the parties agree to seek prior written approval of the other party for all the services etc., before proceeding future with any work/assignment entrusted to it. Approvals on timelines for rendering services would be as per mutual agreement between the parties on a case-to-case basis.


## **3. Records**

Neither party shall be liable for any default, delay, or lapse occurring due to events beyond their control, including riots, strikes, war, or any other acts of God.






## **7. Termination**



PREAMBLE

This Memorandum of Understanding (MOU) is made between KAILASH CANCER HOSPITAL AND RESEARCH CENTRE governed by Muni Seva Ashram trust, a centre for advanced diagnostic facilities located in Goraj, Vadodara, Gujarat and The Department of Paramedical and Health Sciences (DPHS), Faculty of Medicine, Parul University. KAILASH CANCER HOSPITAL AND RESEARCH CENTRE and DPHS are each a "Party" and together are referred to as the "Parties".

Whereas, Department of Paramedical and Health Sciences, Faculty of Medicine, Parul University and KAILASH CANCER HOSPITAL AND RESEARCH CENTRE believe that for overall skill development in the field of Radiation Physics, Radiotherapy and Nuclear Medicine, contribution from both the institutions will help to achieve common goals.

RECOGNIZING their mutual interest in Radiation Physics, Radiotherapy and Nuclear Medicine Programmes, and recognizing the global nature of today's healthcare problems and the need to address them through academic-hospitals cooperation,

HEREBY agree to encourage collaboration according to the terms and conditions set forth in the following articles.

### Article 1: Fields of Collaboration

KAILASH CANCER HOSPITAL AND RESEARCH CENTRE and DPHS may collaborate within any mutual association agreeable for studying in the field of Radiation Physics, Radiotherapy, and Nuclear Medicine for –

- 1) M.Sc. in Medical Physicist- (2years + 1year Internship)
- 2) Post M.Sc. Diploma in Radiological Physics - (1year + 1year Internship)

### Article 2: Exchange of Faculty

- competent staff who will help coordinate with the students to their best capabilities during their training.
- 3.1.2 All basic facilities will be provided to students for their clinical teaching by KCHRC, Goraj.
  - 3.1.3 Scope of KAILASH CANCER HOSPITAL AND RESEARCH CENTRE would be of providing training & Internship to the students in the respective programmes.
  - 3.1.4 Two organizations would exchange information and data on training and skills.
  - 3.1.5 KAILASH CANCER HOSPITAL AND RESEARCH CENTRE will require prior intimation from the Department of Paramedical & Health Sciences regarding the schedule of the students to be placed for training.
  - 3.1.6 The students will have to follow the instruction given by the Directors of KAILASH CANCER HOSPITAL AND RESEARCH CENTRE and abide by the rules and regulations of the hospital.
  - 3.1.7 The institute may provide the final year students for the job placement at KAILASH CANCER HOSPITAL AND RESEARCH CENTRE if there is a vacancy in the institute.
  - 3.1.8 Students will not be allowed to enter restricted areas without the permission of the competent authority.
  - 3.1.9 Students will strictly follow the rules, regulations, safety protocols of KAILASH CANCER HOSPITAL AND RESEARCH CENTRE.
  - 3.1.10 Students under the impression of any prohibited material (like alcohol, tobacco, smoking, and drug) will not be allowed to enter the hospital premises.
  - 3.1.11 All students will be responsible for their personal belongings, vehicles parked in parking; cash, the hospital will not be responsible for any theft or misplacement of such items.

#### Article 4: Administration and General Provisions

4.1 The Courses would commence under Department of Paramedical and Health Sciences, Faculty of Medicine, Parul University upon the approval of AERB and Academic council of Parul University.





Both the parties shall appoint a single point of contact who will regularly communicate and coordinate for the effective implement and execution of these courses.

4.2 This MoU shall have an initial duration of five years from the date of signature unless either party gives a six-month notice of termination. This MoU may be extended further, in five-year increments, by mutual written agreement.

4.3 Despite the statements and obligations expressed herein, this MoU is a non-binding expression of the current intentions of the Parties, and neither Party will incur nor be bound to any legal obligations or expense hereunder to the other Party until and unless definitive agreements have been negotiated, approved by the necessary management levels of each Party and executed and delivered by authorized representatives of both Parties.

This MoU is signed subject to approval by the appropriate authorities on both sides.

## 5. Termination

5.1 Either party may terminate this MoU by mutual understanding by giving 3 (three) months' notice in writing served on other.

5.2 The parties to the MoU understand that, where a course, as aforesaid, is under continuance, the termination shall take effect only on completion of the subsisting course.

5.3 Save as otherwise set out in this MoU, the termination of this MoU howsoever arising is Without prejudice to the rights, duties and liabilities of either party accrued prior to termination.

## 6. Confidentiality

6.1 Each party hereto agrees with the other:

- To keep information in strict confidence and secrecy.

6.2 The restrictions contained in above clause shall apply to both the parties during the term of and for (one) year after the termination of this MoU but shall cease to apply to information or knowledge which:

- Has in it's entirely become public knowledge otherwise than through any unauthorized disclosure or other breach of such restriction.
- The other party has consented in writing to the same being disclosed.
- Is or has been independently developed by the other party without reference to or use of the confidential information.

#### 7. Dispute Resolution

- Any disputes and differences whatsoever arising under or in connection with this MoU which could not be settled by parties through negotiations, after the period of thirty (30) working days from the service of the notice.
- Upon approval by each party, this agreement will remain in effect for the period of 5 years, unless terminated earlier by either institution.
- Notwithstanding the above, the period of this co-operation will, if necessary be extended with consent in writing from the parties.

## MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

**THE GUJARAT NATIONAL LAW UNIVERSITY, GANDHINAGAR, INDIA**

**PARUL INSTITUTE OF LAW, PARUL UNIVERSITY, VADODARA.**

Parul Institute of Law, Parul University, Vadodara (PIL-PU) and Gujarat National Law University (GNLU), Gandhinagar, India, each a "party" or "institution," wishing to establish a cooperative relationship through mutual assistance in the areas of education and research, agree as follows:

### 1. SCOPE OF COLLABORATION

1.1. **General Scope.** Each institution may offer to the other opportunities for activities and programs, such as teaching, research, exchange of faculty and students, and staff development that will foster a collaborative relationship.

1.2. **Specific Activities:** The purpose of this MoU is to develop academic and scholarly partnership through means of various programmes and activities and to promote mutual cooperation between the two parties to further promote their individual mandates.

1.2.1. The Parties agree to co-operate in the following areas:

1.2.1.1. Academic exchange programmes for students and faculty;

1.2.1.2. Collaborative research and exchange of scholar;

1.2.1.4. Exchange and access of academic publication materials or other information; and

1.2.1.5. Any other programmes to be mutually agreed upon.

1.2.2. While exchanging scholars and participating in seminars and conferences, the home institute shall bear for the travel and incidental expenses whereas the host institute shall make arrangements for local hospitality.

- 1.2.3. The development and implementation of specific activities based on the MOU will be separately negotiated and agreed between the parties.

## 2. RENEWAL, TERMINATION AND AMENDMENT

- 2.1. **Duration:** This MOU shall remain in force for **five years** from the date of the last signature. Either party may terminate this MOU by providing 60 days' advance written notice to the other party.
- 2.2. **Extension and Renewal:** The parties may extend or renew this MOU by agreement, confirmed in a written amendment signed by each party's authorized signatory.





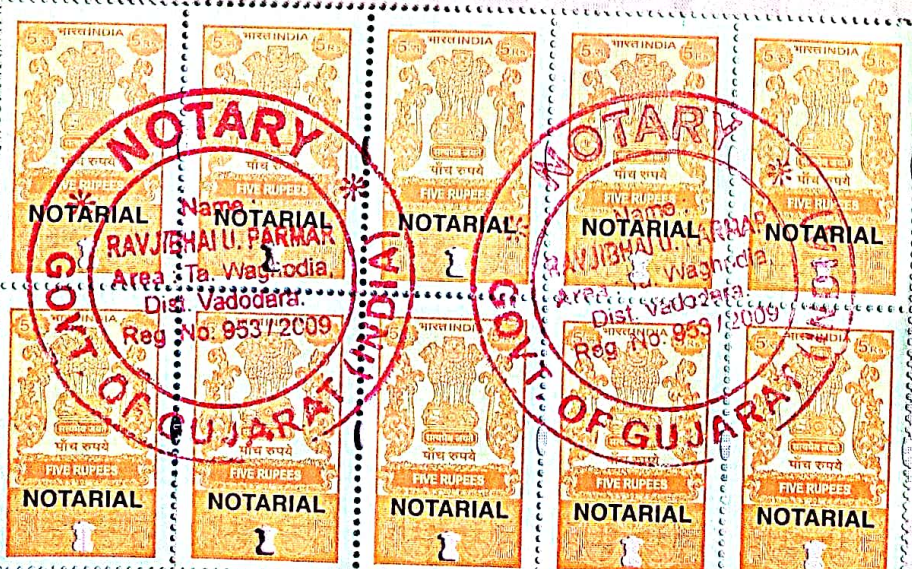

**1. Scope of MOU**

- Udayan Care ensures the shalini shall follow all the rules and regulation of the Institution.

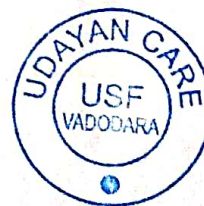
- Udayan Care shall encourage and motivate shalini to perform their best in academics.

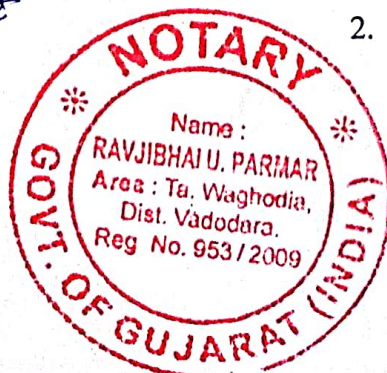
